Had the client been convicted of at least one count for each victim under the dual victim allegation, the penalty would have increased sharply in severity: the client would have been sentenced to life in prison for each count, instead of 15 years for each count.

Following a six-day trial in December, the jury returned with a verdict of not guilty on all four counts of lewd and lascivious conduct. The client was found guilty only of simple battery for one of the charges.
