For each area of HR services, respondents were asked to type in the name of the company they would use – no drop-downs, no prompting.
- In 2012, a total of 1,191 HR practitioners from across all industries participated in the survey. All respondents were manager, director, VP or GM level which means the results of the survey are the true reflection of senior HR professional sentiment.
