The FDA On Vaginal Mesh Complications

"The FDA is issuing this update to inform you that serious complications associated with surgical mesh for transvaginal repair of POP are not rare. This is a change from what the FDA previously reported on Oct. 20, 2008. Furthermore, it is not clear that transvaginal POP repair with mesh is more effective than traditional non-mesh repair in all patients with POP and it may expose patients to greater risk."

A California woman has already been awarded \$5.5 million in compensation for her mesh injury after trial of her case against vaginal mesh manufacturer C.R. Bard. The decision has been characterized as "landmark". This is the very first victory of its kind in the United States for a woman who sued a medical device manufacturer. This award was because of injuries suffered from the vaginal mesh implant.
