

## The Driscoll Firm Files Suit for Child Injured During Delivery

According to the filed Complaint, on November 7th, 2008, Milagro Gaylor, the mother of Jasmine, went to the Johnston Memorial Hospital Emergency Department for severe pain, and was found to have contractions 2 or 3 minutes apart. She was also found to be bleeding, and nurses noticed that the fetal heart rate was unusually variable. Dr. Lavigne was alerted to these issues, and his instructions were to continue to observe the patient.

Between approximately 2:00 a.m. and 7:33 a.m., Ms. Gaylor continued to experience serious pain and vaginal bleeding, and the fetal heart rate remained highly variable. After 7:33 a.m., nurses contacted another physician, who, upon examination, decided to perform a C-Section, her suspicion being that placental abruption had occurred. Following the procedure, the surgical pathology report found that, indeed, placental abruption had occurred.

As a result of the delay in performing the C-Section, Jasmine Gaylor has undergone a substantial number of operations for a wide range of medical conditions. Therefore, in order to compensate Jasmine and her parents for the costs of medical treatment and the other consequences which may arise from her difficult delivery, the attorneys of The Driscoll Firm are seeking \$10 million in damages to help the family in this trying time.
