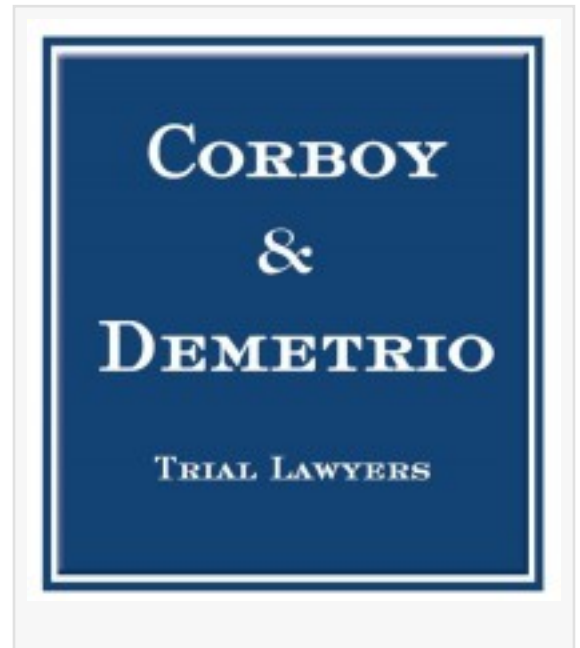


Corboy & Demetrio Named to 2014 'Best Law Firms' by U.S. News & Best Lawyers
