Aligned with these significant changes in the new standard, our training development team and consultants have all contributed to the creation of a brand new ISO27001 Certified ISMS Lead Implementer course."

The ISO27001 Certified ISMS Lead Implementer classroom training course is scheduled to first run in London on the 22nd - 24th January. Delegates who successfully complete this Advanced Level course and exam will be awarded the Certified ISMS Lead Implementer (CIS LI) qualification
