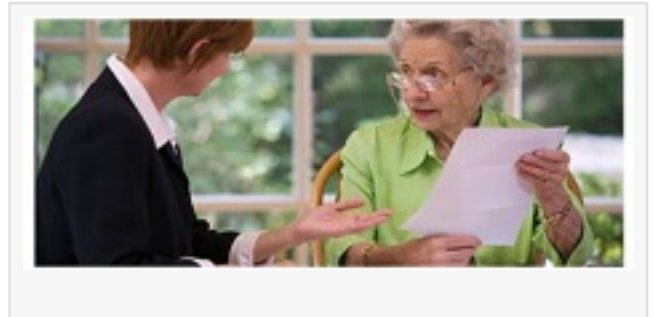


# Leading Lawyer On Elder Law In Chicago Helps Draft State Financial Guidelines For Fiduciaries
