The 7th annual conference will bring together an an array of developers in the unconventional arena to identify and overcome barriers to project developments.

LONDON, UNITED KINGDOM, January 27, 2014 /EINPresswire.com/ -Councils that back "fracking" will get to keep more money in tax revenue as part of an "all-out" drive to promote drilling, Prime Minister David Cameron has said. Local authorities would



receive all the business rates collected from <u>shale gas</u> schemes - rather than the usual 50%. The government says projects will support 74,000 jobs and reduce bills. Furthermore, Energy Minister Michael Fallon said local councils could benefit by up to £10m per wellhead if shale gas was successfully extracted in their communities, through the 1% levy on revenues. This would be on top of the business rates they would receive from companies involved in drilling. "We want local councils and local people to benefit from this exploration. We expect 20 to 40 wells to be drilled in exploration over the next couple of years and I think it's very important that local communities see some of the benefit".

Against this backdrop, SMi's 7th annual <u>European Shale Gas</u> conference will explore how shale gas exploration has affected different regions across the world including the US, Australia and Poland with industry insight from Breitling Oil and Gas, PGNiG, BNK Polska SP z. o.o. and BP.
