For those who are not yet familiar with the process, advance knowledge of each stage of the process and associated costs should help in making informed business decisions.

The workshop, scheduled for 1 hour, including question and answer session, will be held on Thursday, 13th March at 4 pm, at the offices of Kadmos Consultants in Wembley Park, London. The cost is £45+VAT per participant. Early registration is recommended.
