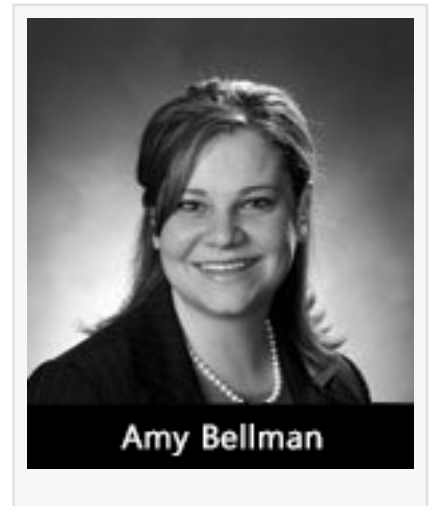


Fidelity National Timeshare Names New Vice President-Division Counsel - Amy Bellman was formerly with Baker Hostetler
