Todd Naber is proud that Naber Specialty Grains is part of the backbone of Saskatchewan's economy. The province comprises forty-four percent of Canada's total cultivated farmland. A thriving Saskatchewan crops industry contributes to and benefits from the increasing local and global demand for food, feed, fuel and fiber. The newest agricultural economy to be developed is renewable biofuel production or agricultural biomass, which is marketed as ethanol or biodiesel. At 251,718 square miles, Saskatchewan is nearly the size of Texas.
