In the 90's, a string of investments were made bringing many brands under the Tyco healthcare roof. Kendall was one of the many. In 2007, Tyco International spun off its healthcare division, which renamed itself, Covidien, which comes from the Latin, roots meaning together and life. Covidien believes very firmly in its mission statement:

Create and deliver innovative healthcare solutions, developed in ethical collaboration with medical professionals, which enhance the quality of life for patients and improve outcomes for our customers and our shareholders.

And Covidien works hard to bring those goals to life every day.
