Sabulis says that a building must score at least 40 points from a total of 110 points, to qualify a building as a [LEED Certified building](#). Utilizing Intus Windows with Guardian SunGuard glass, he says, can earn a project up to 34 LEED points. While LEED is a voluntary standard, more businesses and homeowners are making it a top priority, he concludes.

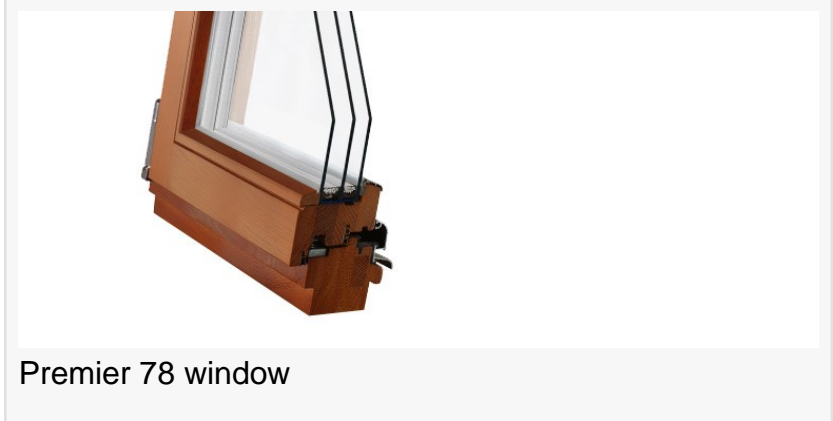
