Hard-hitting statistics reveal that 81% of large organisations and 60% of SMEs suffered a security breach in 2013. Infection by viruses or malicious software was the biggest cause of data breaches, at 73% for large organisations and 45% for SMEs. Unauthorised outsiders were responsible for 55% of the breaches at large organisation and 33% at SMEs. Denial of service attacks were estimated at 38% for large organisations and 16% for SMEs, according to the 2014 Information Security Survey quoted in the infographic.

Sony, eBay, Hotel Hippo, Racing Post and Adobe were among the organisations affected by data breaches in the UK over the past five years. Some of those organisations managed to recover, albeit suffering financial losses and a damaged reputation. Others, like Hotel Hippo, were not so fortunate and were forced out of business. Strikingly, the National Cyber Security Alliance estimated that 60% of small organisations close down within six months after suffering a data breach.

Alan Calder, founder and executive chairman of IT Governance, says, "The cyber threat environment is constantly changing and we must all take action to respond to these changes. Dealing with information security from a proactive point of view will ensure organisations can continue to thrive even in an environment marked by increasing cyber crime. Tested and proven international frameworks like ISO27001 are the way forward."

The Boardroom Cyber Watch Survey 2014 revealed that 68% of UK organisations have been asked for IT security credentials by customers.

The latest ISO Survey of Management Systems Standard Certifications - 2013 shows that certification to the ISO27001 has grown by 14% globally and by 25% in Europe. In 2013, ISO27001 certificates in the UK were up by 13% on 2012.
