


Corboy & Demetrio Files Lawsuit against Airline in Plane Crash near Midway

Roberta Rolinskas, 82, and Raymond Rolinskas, 84, were asleep inside their bedroom when the plane crashed through their home, stopping just feet from their bed.



The negligence lawsuit names as defendant Central Airlines, Inc., which owns the plane that tore through the side of the couple's brick home, ripping open a huge hole

in their living room and then blasting through the living room wall, ripping a huge hole into their bedroom and crushing everything in its path. The plane miraculously stopped just a couple of feet from the couple.
