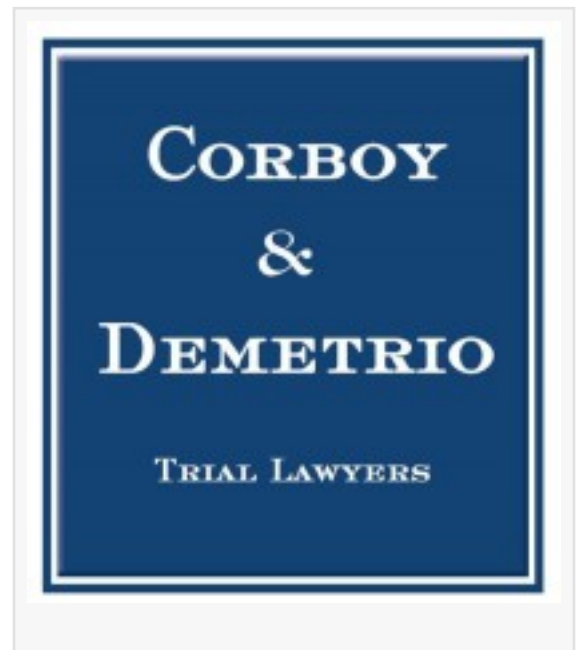


Corboy & Demetrio Named to 2015 Best Law Firms by U.S. News & Best Lawyers
