According to the CDC the states indicated with the highest incidence of mesothelioma include Maine, Massachusetts, Connecticut, Maryland, New Jersey, Pennsylvania, Ohio, West Virginia, Virginia, Michigan, Illinois, Minnesota, Louisiana, Washington, and Oregon.

High risk work groups for exposure to asbestos in Minnesota include US Navy Veterans, power plant workers, oil refinery workers, manufacturing, or industrial workers, plumbers, electricians, welders, auto mechanics, machinists, or construction workers.
