High risk work groups for exposure to asbestos in Massachusetts include US Navy Veterans, power plant workers, shipyard workers, oil refinery workers, manufacturing workers, plumbers, electricians, auto mechanics, machinists, or construction workers. According to the US Center for Disease Control the average age for a diagnosed victim of mesothelioma is 72 years old. Frequently victims of mesothelioma are initially misdiagnosed with pneumonia. This year between 2500, and 3000 US citizens will be diagnosed with mesothelioma. Mesothelioma is attributable to exposure to asbestos.

According to the CDC the states indicated with the highest incidence of mesothelioma include Maine, Massachusetts, Connecticut, Maryland, New Jersey, Pennsylvania, Ohio, West Virginia, Virginia, Michigan, Illinois, Minnesota, Louisiana, Washington, and Oregon.
