


Experts urge increased adoption of Cyber Essentials to protect against basic cyber attacks

"Moreover, for as little as £300, organisations can certify to Cyber Essentials, provided they pass the necessary scans, to prove to themselves and their clients that the required controls have been implemented."

In order to achieve <u>Cyber Essentials certification</u>, companies need to complete a self-assessment questionnaire, which is signed off by a senior company representative and then verified by an external certification body. An external vulnerability scan will also be required if the company has chosen to be certified through a CREST-approved certification body like IT Governance.

The UK Government requires organisations to prove their compliance with the scheme in order to bid for government contracts that involve the handling of sensitive and personal information, and the provision of certain technical products and services.

IT Governance's Cyber Essentials Certification service is designed for organisations that do not require help completing the self-assessment questionnaire and is available as a convenient online service, saving time and money.
