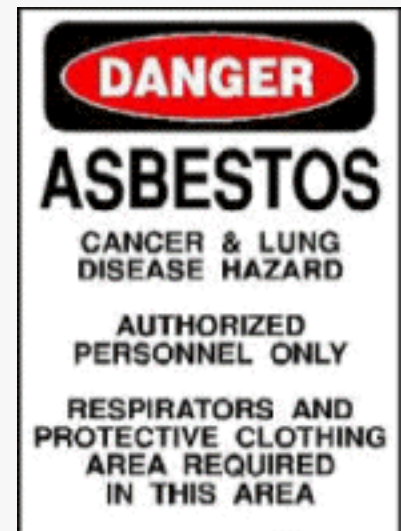

High risk work groups for exposure to asbestos in Kentucky include Veterans of the US Navy, power plant workers, oil refinery workers, factory workers, plumbers, electricians, miners, auto mechanics, machinists, and construction workers.
