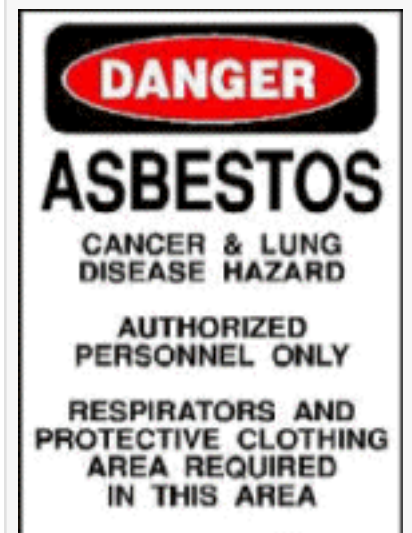

The average age for a diagnosed victim of mesothelioma is 72 years old. This year between 2500, and 3000 US citizens will be diagnosed with mesothelioma. Mesothelioma is a rare form of cancer that is attributable to exposure to asbestos.

High risk work groups for exposure to asbestos in North Carolina include Veterans of the US Navy, power plant workers, shipyard workers, steel mill workers, oil refinery workers, pulp, or paper mill workers, factory workers, plumbers, electricians, miners, auto mechanics, machinists, and construction workers.
