

# Really? Garlic Juice Herpes Treatment Gets Patent; CBCD Reviews a Report

that his invention “cured” him of herpes and other ailments. (1) MedPage Today's “Improbable Research” is research that makes people laugh and then think. Research presented on

everywhere. Research that's maybe good or bad, important or trivial, valuable or worthless.”

The Center for the Biology of Chronic Disease (CBCD) recommends that individuals infected with the herpes virus take Gene-Eden-VIR or Novirin.
