


## A NEW REAL-LIFE CHARACTER AMONG PRIVATE INVESTIGATORS IN THE CARIBBEAN

The collection of cases may seem to have been chosen at random, but throughout the book there is an underlying theme that binds everything together – the cold case of Fernandez's father-in-law's murder. The cases themselves set the stage for the development of the main character, from the moment he gets his first big international break, to the actual chronological stage of his father-in-laws murder case investigation as of March of 2015. His coworkers and family also get the spotlight as they play an intrinsic part in his motivations, and ultimate results.

"I believe P.I.'s don't get enough credit for the work they perform on criminal investigations, especially behind the scenes. In this book the reader will see how we help the authorities in the search for evidence, and how sometimes we even put our lives on the line to get the truth," said Fernandez, who has been in this line of business with his firm, Covert Intelligence, LLC, for more than 10 years.
