Port Authority police said TSA screener Margo Grant, 41 snatched a \$7,000 luxury watch left behind by a passenger at John F. Kennedy International Airport. She reportedly took it to a bathroom, but then destroyed it when she saw other TSA agents searching for it. Louree-Grant was arrested and charged with grand larceny and official misconduct, the New York Daily News reported.

Meanwhile, in Denver, <u>newly released footage</u> from a Feb. 9

incident at Denver International Airport shows agent Ty Spicha, 27, fondling male passengers. Apparently, Spicha colluded with a fellow agent, Yasmeen Shafi, 22, who manipulated scanning machines so that male travelers who Spicha found attractive would be identified as female. The scanner would then pick up abnormalities in the passenger's genital region, giving Spicha justification to pat them down.

Shafi reportedly admitted to altering the scans of 10 passengers, and both employees were fired in April for their misconduct The Denver District Attorney's office was "unable to corroborate the victims' claims with any additional facts, and dropped the criminal charges against the pair in July.
