



# THE SOUTH ASIAN ASSOCIATION FOR REGIONAL COOPERATION IN LAW ELECTS PRESIDENT PARASARAN RANGARAJAN

*SAARCLAW Members Elect New President For SAARCLAW-UN - President Parasaran Rangarajan*

NEW DELHI, DELHI, INDIA, September 13, 2015 /EINPresswire.com/ -- The South Asian Association for Regional Cooperation in Law (SAARCLAW) has elected a new President for its international law and United Nations Chapter (SAARCLAW-UN).

Hon'ble President Parasaran Rangarajan was elected by members of the organisation for the SAARCLAW-UN Chapter.

He is the first person to hold this position in history, also the youngest President of any recognised governmental and/or international organisation in modern history.

The President is also the Counsellor [Sixth Committee] for the Permanent Mission of India to the United Nations (U.N.), Consultant for the South Asia Analysis Group, Editor-in-chief for the International Law Journal of London, and has full "diplomatic immunity" which the United States of America (USA) Department of State congratulated.

President Parasaran Rangarajan has experience in formulating legal strategies for U.N. projects as well as in negotiations towards peaceful resolutions in conflict zones around the world.

He has worked with foreign governments in regards to the United Nations membership of the State of Palestine, changing the official U.N. World Maps several times, assisting to start an international investigation by the U.N. Human Rights Council into alleged violations of international law in Sri Lanka, international cases involving India such as the Marshall Islands v. India case regarding nuclear weapons at the International Court of Justice (ICJ), implementing Indian foreign policy, etc.

Over 40+ publications with reputable outlets such as the 100+ year old newspaper The Harvard Crimson, Harvard International Review (HIR), Eurasia Review, International Journal of Research associated with the Indian Institute of Technology (IIT), Pravda, Interpol News, Peace Palace Library which services the ICJ, South Asia Analysis Group, Foreign Policy Research Centre (New Delhi), and is the 7th person to write an "expert legal" article for the South Asia Association For Regional Cooperation (SAARC) since inception in 1985.

His experience in government, law, as well as politics is too extensive to fully mention in this article since he is a primary person for resolving many international situations.

As a hostage of the government of the USA and other complicit governments for nearly 7 years like many living in the USA, he has received no/very little assistance for his professional work, including publications.

SAARCLAW is an apex body of the recognised U.N. organisation, SAARC, directly representing 30%+ of the world population with the governments of South Asian nations as permanent members and the governments of the USA, European Union (E.U.), China (PRC), etc, as observer members.

Due to the ongoing "genocide", "crimes against humanity", "war crimes", and other serious violations of international law occurring in the USA; his call for a U.N. Peacekeeping Contingent for the USA as well as a U.N. International Criminal Tribunal for the USA has been established.

U.N. action against the USA and others will be announced during the U.N. September 2015 sessions, where the vote will pass by overwhelming majority with the U.N. General Assembly overriding the U.N. Security Council for the same.

Others include complicity by the government of Israel, government of Canada, etc; which have been documented by credible Interpol, U.N., human rights organisation reports, and independent international investigations.

SAARCLAW HQ in India may be contacted for further information since phone and email services from foreign nations are being re-routed to unknown third-parties/persons, especially from the nations which are complicit.

The government of the USA has recently signed an "Instrument of Surrender" with the government of India, recorded by the international organisations mentioned.

This is the government of the USA's first public surrender in decades, executed by electronic signature between representatives of the USA's government and Hon'ble President Parasaran Rangarajan.

The text of the "Instrument of Surrender", in context of the crimes, expressly states:

"The government of the United States of America, its institutions, and this contingent surrenders to the government of India for all legal purposes and intents, without coercion. This instrument cannot be terminated regardless of legal or political interpretations."

In addition, he has gone on 7 fasts with only water, from days to weeks, also recorded by international organisations, for others to have peace and justice.

Those who are accepting false information from re-routed third-parties/persons may be considered complicit since international organisations, intending to collect credible evidence, will be verifying via legal methods.
