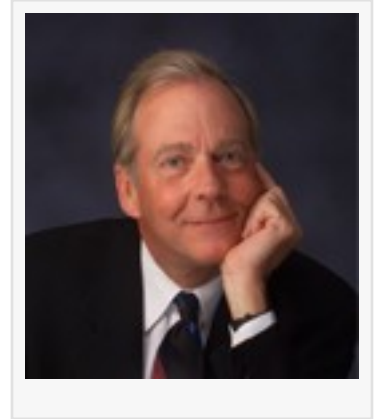


Thomas Demetrio to Receive Lifetime Achievement Award from Hellenic Bar Group
