- •A Singapore citizen
- •Bermanent resident
- AntrePass holder
- Employment Pass holder or
- Dependent Pass holder

Duties of the Nominee Director may include at a minimum:

- •Conducting the Annual General Meetings
- •Biling the Annual Return to Accounting Compliance Regulatory Authority of Singapore (ACRA)
- •Bubmitting corporate taxation returns to Inland Revenue Authority of Singapore (IRAS)

"This is a low-risk way for foreign-owned businesses to adhere to the Singapore government's rules since the Nominee Director is held accountable for all statutory requirements. That means if Acrafile were the Nominee Director for a company, Acrafile would be responsible for meeting

those compliance needs," said Wong.

Singapore is a popular location for entrepreneurs and start-ups due to its political stability and its pro-business and tax-friendly policies.
