High risk work groups for exposure to asbestos in Nevada include Veterans of the US Navy, former power plant workers, shipyard workers, oil refinery workers, steel mill workers, miners, factory workers, miners, plumbers, electricians, auto mechanics, machinists, and construction workers. According to the CDC the average age for a diagnosed victim of mesothelioma is 72 years old. This year between 2500, and 3000 US citizens will be diagnosed with mesothelioma. Mesothelioma is a rare form of cancer that is attributable to exposure to asbestos.

According to the CDC the states indicated with the highest incidence of mesothelioma include Maine, Massachusetts, Connecticut, Maryland, New Jersey, Pennsylvania, Ohio, West Virginia, Virginia, Michigan, Illinois, Minnesota, Louisiana, Washington, and Oregon. However mesothelioma can happen in Nevada.
