50600 data centre standard. From the original audit came an improvement plan and management training that led to the data centre being accredited to one of the Classes of Availability defined in the EN 50600 standard.

EN50600 is Europe's new data centre facilities and infrastructure standard published by CENELEC. CENELEC is the European Committee for Electrotechnical Standardization and is responsible for standardization in the electrotechnical engineering field. EN50600 is published in each EU member state as the national standard for data centres. Under the EU Directive on Public Procurement organisations in Europe spending public money must use CEN, CENELEC or ETSI standards where they exist.

EN50600 has five infrastructure components

- EN 50600-1:2012 Data centre facilities and infrastructures. General concepts
- EN 50600-2-1:2014 Data centre facilities and infrastructures. Building construction
- EN 50600-2-2:2014 Data centre facilities and infrastructures. Power distribution
- EN 50600-2-3:2014 Data centre facilities and infrastructures. Environmental control
- EN 50600-2-4:2015 Data centre facilities and infrastructures. Telecommunications cabling
- EN 50600-2-5(draft) 2-5. Data centre facilities and infrastructures. Security systems

EN50600 has four levels or classes of operation to describe resilience and redundancy in the data centre for facilities and utility design and operation.
