High risk work groups for exposure to asbestos in North Carolina include Veterans of the US Navy, power plant workers, shipyard workers, steel mill workers, oil refinery workers, pulp, or paper mill workers, factory workers, plumbers, electricians, miners, auto mechanics, machinists, and construction workers. Typically the exposure to asbestos occurred in the 1950's, 1960's, 1970's, or 1980's.

According to the CDC the states indicated with the highest incidence of mesothelioma include Maine, Massachusetts, Connecticut, Maryland, New Jersey, Pennsylvania, Ohio, West Virginia, Virginia, Michigan, Illinois, Minnesota, Louisiana, Washington, and Oregon.
