

addition, some businesses are charged a minimum monthly fee, if there are not enough processed payments in a given month. Along with all of the above is a batch fee, charged every time data is sent, about every 24 hours.

In just one month, these seemingly insignificant fees can add up to hundreds or thousands of dollars. Money paid in credit card processing fees is derived from a business' bottom line, funds which could be used in a more productive manner. 
