This year between 2500, and 3000 US citizens will be diagnosed with mesothelioma. Mesothelioma is attributable to exposure to asbestos.

According to the CDC the states indicated with the highest incidence of mesothelioma include Maine, Massachusetts, Connecticut, Maryland, New Jersey, Pennsylvania, Ohio, West Virginia, Virginia, Michigan, Illinois, Minnesota, Louisiana, Washington, and Oregon.

High risk work groups for exposure to asbestos in Rhode Island include US Navy Veterans, power plant workers, shipyard workers, oil refinery workers, industrial workers, plumbers, electricians, auto mechanics, machinists, or construction workers.
