The average age for a diagnosed victim of mesothelioma is about 72 years old. This year between 2500, and 3000 US citizens will be diagnosed with mesothelioma. Mesothelioma is a rare form of cancer that is attributable to exposure to asbestos.

High risk work groups for exposure to asbestos in Oregon include Veterans of the US Navy, power plant workers, factory workers, truck building workers, maritime workers, pulp and paper mill workers, plumbers, electricians, welders, auto mechanics, machinists, and construction workers. In most instances the diagnosed person's exposure to asbestos occurred in the 1950's, 1960's, 1970's, or 1980's.
