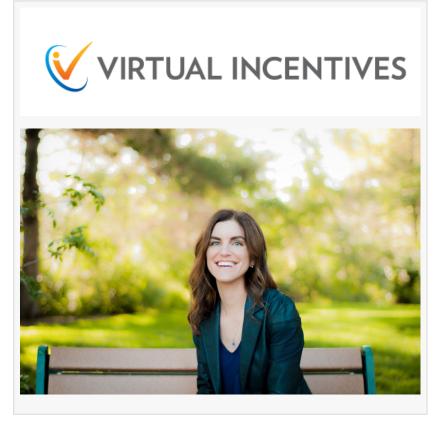


Virtual Incentives' Michelle Andre Honored as Winner in the Annual 2016 Women World Awards®
