Transgender individuals, despite genders with which they now identify, must use bathrooms that match the genders on their birth certificates. Firmly against discrimination in any form, AAOA is committed to a mission of ensuring equal housing opportunities for everyone and helping our members comply with federal laws that may contradict local legislation.

In making a decision to support the LGBT community at this time, AAOA joins a host of other notable companies and celebrities, including PayPal, Google, Apple and Bruce Springsteen, raising concern of the new laws.
