The purpose of the action is to demand the Repeal of the Peace Officers Bill of Rights. The families will speak out about their loved ones whose lives were taken by Police Action. Rarely is an Officer arrested or prosecuted in these cases. The action will start be from 9 am - 2 pm. The bill



protects Law Enforcement Officers from Prosecution by withholding previous offenses. The families contend that the Bill is unnecessary as Law Enforcement has the protection of DA's and Courts and are seldom prosecuted. Once an Officer kills or impairs someone Victims Assistance offers no help or assistance to the family. It is a double slap in the face that elected officials and the Governor signed this Bill into existence.
