High risk work groups for exposure to asbestos in Nevada include Veterans of the US Navy, former power plant workers, shipyard workers, oil refinery workers, steel mill workers, miners, factory workers, miners, plumbers, electricians, auto mechanics, machinists, and construction workers. Typically- the exposure to asbestos occurred in the 1950's, 1960's,

1970's, or 1980's, and typically the exposure to asbestos did not occur in Nevada.
