High risk work groups for exposure to asbestos in Michigan include US Navy Veterans, auto plant workers, power plant workers, manufacturing workers, plumbers, welders, electricians, auto mechanics, machinists, or construction workers. Typically, these types of workers had significant exposure to asbestos during the 1950's, 1960's, 1970's, or 1980's.

The average age for a diagnosed victim of mesothelioma is 72 years old. Frequently victims of mesothelioma are initially misdiagnosed with pneumonia. According to the CDC the states indicated with the highest incidence of mesothelioma include Maine, Massachusetts, Connecticut, Maryland, New Jersey, Pennsylvania, Ohio, West Virginia, Virginia, Michigan, Illinois, Minnesota, Louisiana, Washington, and Oregon.
