Also appearing as industry experts are Justin Dunaskiss, a Lansing-based lobbyist, Debra Young, who will speak on the petitioning process, and Jamie Lowell of Ypsilanti's 3rd Coast, who in 2009 co-founded the first licensed medical marijuana dispensary in the U.S. east of the Mississippi River.
