On October 15th, Star Mountain Capital, along with family and friends will be participating in a 5km family fun run in Central Park for Cancer Research

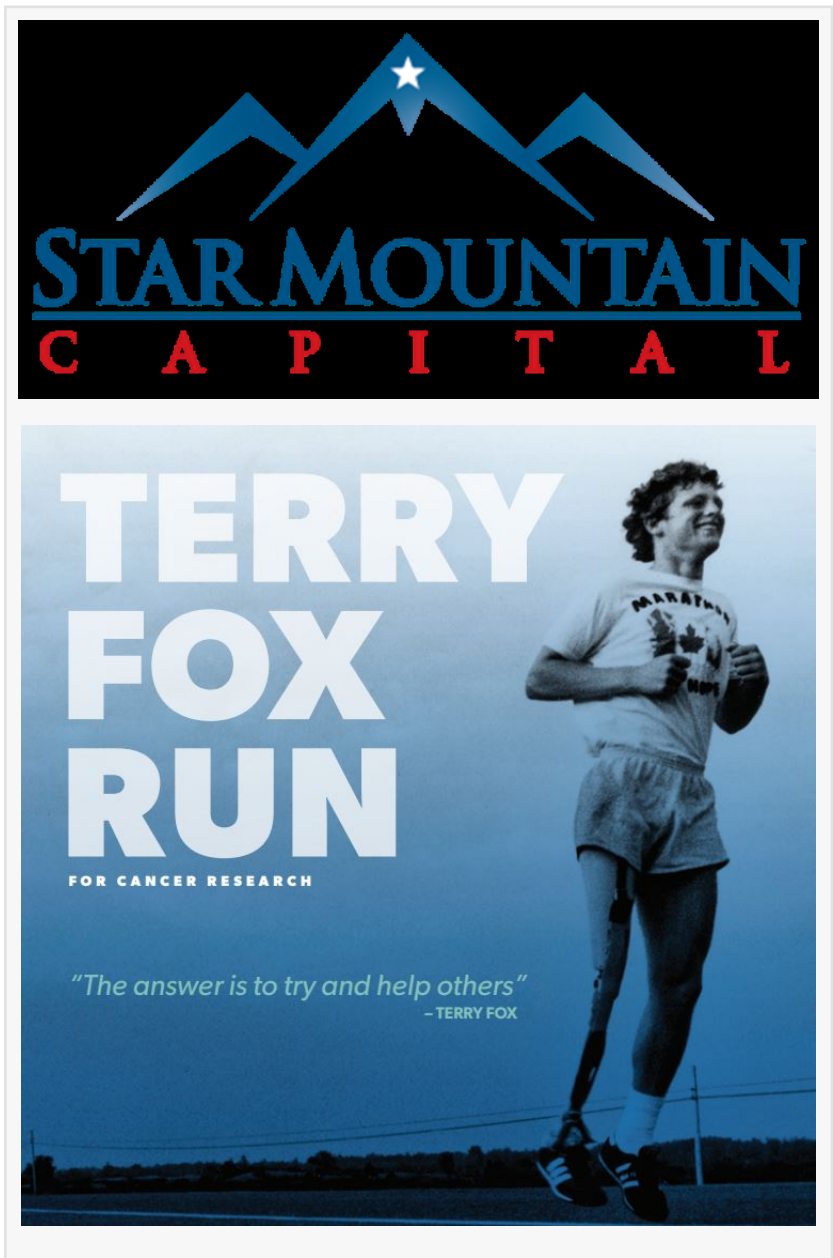

At 18, Canadian Terry Fox learned that due to bone cancer his right leg would be amputated above the knee. During his ordeal, Terry became convinced that a cure for cancer could be found through cancer research, but funds were in short supply.

Terry decided to run across Canada, some 6,000 miles, to raise money for cancer research. On April 12, 1980 at St. Johns, Newfoundland, Terry dipped his artificial leg in the Atlantic Ocean and began what he called the "Marathon of Hope". For the next 143 days he ran 26 miles per day, the marathon distance, crossing 3,300 miles until, on September 1, 1980 near Thunder Bay, Ontario, he was forced to stop. The cancer had spread to his lungs and he died on June 28, 1981, a month shy of his 23rd

birthday.

Since his death, thousands of runs have been held in Canada and throughout the world in Terry's name to raise funds for cancer research.

2014, he unfortunately lost another amazing person to this disease, his loving aunt, who played a motherly role for him after his mom passed (in addition to raising her 4 children). Brett believes that one day we will be able to beat cancer, and the more research we do, the sooner that day will come.
