The Granterre Consortium is a cooperative that includes 36 dairies which produce Parmigiano Reggiano, thereby representing more than 600 farms (which produce the milk). Parmareggio has two production plants (the main plant in Modena, near the Headquarters, and one in Montecavolo) in which it makes the wheels of Parmigiano Reggiano. Innovation has been an essential element that has allowed for the development of new products through intensive research activities and, more importantly, new consumption occasions for Parmigiano Reggiano.
