- \* In a commercial project, like a casino, the exposure could have been extreme prior to 1980.
- \* Commercial or residential plumbers anywhere in Nevada could have been exposed to asbestos on a regular basis if they were doing plumbing repairs that involved removing sections of walls or ceilings insulated by asbestos.
- \* Most residential or commercial plumbers prior to the 1980's had experience working on boilers, pumps, furnaces, or pipes which may have contained parts wrapped with asbestos.
- \* Plumbers involved in a major commercial project such as the construction of a casino/hotel could have had daily exposure for months or longer. <http://Nevada.MesotheliomaVictimsCenter.Com>
