OIAC continues to warn of Iranian regime’s growing influence in the Middle East and laments international inaction on Iran’s atrocious human rights record, a fact admirably noted by Mr. Tillerson. Iranian regime presently executes more of its citizens (per capita) than any other sovereign nation.

[some 30,000 political prisoners](#) still serve at the highest levels of the Iranian government.

We praise the administration for its firmness on Iranian regime & its misdeeds. We additionally appreciate congressional leaders who through H.Res.188 and other measures are working to keep masterminds of the 1988 massacre and Iran’s Islamic Revolutionary Guards Corps accountable for their crimes against humanity.


