

MMA Insider Recognizes Tae Hyun Bang's Internal Struggle During Alleged Fixed Fight

An MMA insider describes an internal struggle taking place in Tae Hyun Bang as he faces the reality of his circumstances in the UFC's first fixed fight scandal

NEW YORK CITY, NEW YORK, USA, May 9, 2017 /EINPresswire.com/ -- The first real fight fixing scandal has taken place within the premier league of Mixed Martial Arts. The Ultimate Fighting Championship held an event in 2015 that was located in South Korea that has made headlines lately as one of the South Korean fighters on the undercard has admitted to accepting a bribe from Korean gangsters to throw the fight. Bribes like these have plagued the international MMA community in the past with other organizations that have been shut down in the face of organized crime and this is an astonishing first for the UFC.

The odds shift that alerted UFC officials to the possible nefarious outcome of the fight was reportedly one of the largest in history. The alarming news caused UFC officials to approach both fighters before the fights to warn them of what they had suspected. A popular Korean news source has stated publicly that the fighter had a change of heart at the last minute after UFC officials made it known that they had suspected the fighter of nefarious activity in the lead-up to the fight. The fighter went on to win the fight in a closely contested split decision and has since turned himself in to Korean authorities out of a concern for his personal safety.

An MMA writer and professional fighter in his own right recognized the internal struggle of the fighter in question as he re watched the fight from 2015 in South Korea. The <u>article that he has written</u> offers a unique perspective into a closely contested bout between Tae Hyun Bang and Leo Kuntz that outlines the internal struggle of the South Korean fighter, Tae Hyun Bang. He posits that the fighter didn't in fact have a change of heart, but instead was troubled with inner struggle on how to satisfy both parties of which had laid claim on him. He then defines the mental space that he perceived the South Korean fighter to be in to add a level of understanding to the fighter and to lay the framework for the speculations that he made on the fight. He then points out various situations within the first round where he can see the fighter struggle with what to do based on the outside variables that have been presented to him.

The writer admits that these claims are impossible to make without speculating and that they couldn't possibly be confirmed without an outright interview of the fighter in question. "I don't know of anything I'm about to say to be absolutely true, I simply could not confirm these things without directly interviewing Tae Hyun Bang... The speculations that you are about to read are simply to spur interesting thoughts... "Despite the speculation, the article serves as a vehicle for thought and looks to incite interesting discussion through thought provoking ideas that are designed to get people more involved with this first ever fight fixing scandal in the UFC.
