The regulation affects any company that controls or processes the personal data of European Union (EU) citizens, regardless of that company's physical geographic location. The GDPR has been noted for the severity of its potential fines, up to EUR 20 million or 4% of a non-compliant company's annual revenue, whichever is greater.

"Twelve months is a short amount of time in the corporate world, and it is critical that companies who operate in the EU accelerate their privacy planning," said MENTIS' founder and CEO Rajesh Parthasarathy. "In addition to our compliance-ready suite of security solutions, we are launching a central location that will bring all the relevant information together as a service to our customers."

<u>MENTIS' GDPR Update Central</u> will be a live resource with reporting, blog posts, and practical information on how the GDPR will affect business and what companies need to do to be in compliance. Data in the cloud, for instance, is one area that will come under increased scrutiny.

Compliance has been a strong suit of MENTIS since its founding. - In applications where traditional DDM approaches have struggled, organizations should take advantage of innovative DDM solutions at the data virtualization or alternative application tiers.
