and stabilizing the dentition in ways I did not previously think was possible.”

LANAP treatment targets the source of the inflammation without hurting or removing any healthy gum tissue to slow or stop attachment loss, decrease pocket depth, and allow the body to recover from the chronic infection without the need for scalpel or sutures.
