It was further alleged that on numerous occasions, Camarco had drawn checks on her customers' accounts with checks written out to "C Investments". Camarco had written the checks without customers' permission and used that money for personal expenses.

Sonya Camarco was licensed with LPL Financial from February 2004 to August 2017. She worked in Colorado Springs, Colorado. She operated a number of entities, including SDC Advisory, [Camarco Investments](#), Inc. (also known as "C Investments") and Camarco Living Trust.
