This is crucial for those in the public sector that hold sensitive data, such as financial and biometric details of individuals. By law, these particular organisations will be required to appoint a data protection officer (DPO).

The founder and executive chairman of IT Governance, Alan Calder, said that "public sector organisations have a responsibility to improve their underlying security practices and organisational governance to ensure minimal risk of cyber threat.

"The GDPR and the Network and Information Security (NIS) Directive introduce obligations to deal with information security incidents and report data breaches to the relevant supervisory authority without undue delay. Therefore, organisations will need to be prepared and equipped to deal with incidents."

The conference will take place on 8 November at Adelphi House in Salford.
