To illustrate what the California Corporate Whistleblower Center is talking about in July 2017 the Department of Justice announced a Midwest based healthcare company has agreed to pay approximately \$19.5 million to resolve allegations pertaining to the submission of false claims for medically unnecessary rehabilitation therapy and hospice services to Medicare.

The settlement resolves allegations that, from January 2008 through December 2012 the healthcare company submitted bills to Medicare for medically unnecessary rehabilitation therapy services at 18 skilled nursing facilities. The government contended that the therapy services were provided at excessive levels to increase Medicare reimbursement for

those services.
