The average age for a diagnosed victim of mesothelioma is about 70 years old. Frequently victims of mesothelioma are initially misdiagnosed with pneumonia. This year between 2,500 and 3,000 US citizens will be diagnosed with mesothelioma.

High-risk work groups for exposure to asbestos in Tennessee include US Navy Veterans, power plant workers for the TVA, manufacturing or industrial workers, plumbers, electricians, auto mechanics, machinists, miners, or construction workers. Typically, the exposure to asbestos occurred in the 1950's, 1960's, 1970's, or 1980's.

The states indicated with the highest incidence of mesothelioma include Maine, Massachusetts,

Connecticut, Maryland, New Jersey, Pennsylvania, Ohio, West Virginia, Virginia, Michigan, Illinois, Minnesota, Louisiana, Washington, and Oregon. Mesothelioma also happens in Tennessee.
